These guidelines are meant to ensure that students belonging to Socio-Economically Disadvantaged Groups (SEDGs) have a safe and secure environment and equitable access to quality education in Higher Educational Institutions (HEIs), as specified in the NEP 2020.

Universities and Colleges should prepare guidelines and principles, develop curriculum and collaborate with government and non-governmental organizations to conduct outreach programmes

Appropriate sensitization programmes should be introduced and regularly organized for all teachers, administrators, functionaries, and students of HEIs, so that the latter become more open to valuing the relevance of inclusive policies

Interventions to make HEIs more Inclusive, Equitable and Sensitive to SEDGs

HEIs may undertake the following appropriate affirmative actions to facilitate learning for all students, with special emphasis on Socio-Economically Disadvantaged Groups (SEDGs) -



Bridge Courses

- ➤ To overcome deficiencies in learning
- ➤ To perform at par with other students
- To act as a buffer for the new entrants
- To facilitate smooth transition into hardcore engineering professional courses
- ➤ To provide basic knowledge on core courses
- To equip students with the necessary knowledge and confidence



Earn-while-Learn

- To enhance employability skills and career preparedness
- ➤ To reduce the drop-out rate
- ➤ To reduce the parental burden of education expenses
- To acquire the requisite competence for students
- ➤ To have hands-onexperience while learning
- ➤ To increase networking possibilities for students and also institutions



Outreach Programme - SEDGs Special Education Zones

- ➤ To help, uplift and support SEDGs
- ➤ To facilitate smooth transition of students from SEDGs into HE
- To provide services such as language translation, recording services, and assistive technologies
- ➤ To provide professional, academic and career counselling

Establishing Equal Opportunity Cell at the HEIs

To provide socioemotional and academic support and mentoring
